VHCP Management III, LLC is the general partner of Venrock Healthcare Capital Partners III, L.P. and manager of VHCP Co-Investment Holdings III, LLC, each of which holds shares in Synairgen plc falling below the notifiable threshold and in aggregate hold shares in Synairgen plc which represent 3.20% of the voting rights.

All percentages are based on the notified current issued share capital of Synairgen plc of 149,433,442 ordinary shares.
